# GRAYS HARBOR FIRE DISTRICT 5 BOARD OF FIRE COMMISSIONERS REGULAR MONTHLY BUSINESS MEETING

#### February 8, 2020

The Grays Harbor Fire District 5 Board of Commissioners met at the Elma Fire Station, located at 112 N. 2<sup>nd</sup> Street, Elma, WA 98541, for the regular monthly business meeting at 7:00 p.m. on February 8, 2021 and on Zoom.

#### 1. Call to Order:

The meeting was called to order at 7:03 p.m. by Commissioner Hauge.

Commissioners listened to reason for change and denied change. Put to a vote, Commissioner Crisp and Hauge voted in favor to approve agenda as is presented, Commissioner Paton abstained from voting.

one repair estimate after unanimous vote on estimate received entered during January 12, 2021 regular meeting.

Chief confirmed we are now on a month-to-month contract with Zoll. We currently working with ERS and Zoll to extract historical data and merge with City of Elma database. No firm timeframe at this point.

a. Add position 10 a 40-hour a week Firefighter/EMT.

Chief presented board with flowchart of new projected payroll coast for additional employee including call volume peak times over the past 3 years.

Commissioner Patton expressed concern regarding dropped transfers and requested a report of those.

After further discussion regarding adding position 10 and the financial impact to the district the board has asked the chief to request and MOU from the Union regard discontinuing vacation buyout.

Commissioner Hauge express concern regarding current call volume and the recent number of 911 calls the administration staff has been having to cover.

Commissioner Patton express concern over hiring one full-time person instead of hiring more part-time persons. Chief express ongoing issuing with part-time staffing.

Position 10 has been tabled

#### b. Engine 5-11 (KME)

Used KME has been given to the District, KME can replace surplus E5-11

Commissioner Hauge made a motion to except the KME engine, Commissioner Patton second the motion with discussion.

Concern expressed over used equipment and cap for future expenses. Commissioner Crisp let the board know he would get history of maintenance records from City of Olympia. Commissioner Hauge amends his original motion to included once the District has reviewed maintenance records and if we find those records to be favorable, we will except the KME. All voted in favor of amended motion. Motion passed.

Commissioner Patton made a motion t expect resolution 21-3. Commissioner Crisp second the motion. All voted in favor, motion passed.
